Site Narrative: An investigation of the presence of per- and polyfluoroalkyl substances (PFAS) is underway. The PFAS Areas of Potential Interest (AOPIs) at this time are the Current Fire Station (Bldg. 400), Fire Station Support Facility (Bldg. 400B), Helipad and aqueous film-forming foam (AFFF) Equipment Testing Area, AFFF Storage Area (Bldg. 325), and Temporary AFF Storage (Bldg. 310A). The current and reasonably anticipated land is to remain the same. There is a potential for groundwater originating at the AOPIs may also flow off-post. The findings of the investigation will be presented in a combined preliminary assessment (PA) /site inspection (SI) report. The preliminary assessment (PA) phase concluded with the identification of five areas of potential interest (AOPI). Sampling of these sites for the SI phase was conducted June 29-30, 2020. The groundwater and shallow soil (0.5 to 2.0 feet) sample results indicated levels below the 2019 Office of the Secretary of Defense (OSD) industrial/commercial or residential risk screening levels. Data from the SI showed PFAS at all AOPIs below 2021 OSD screening levels (below 40 parts per trillion). No further action was to take place and the site was expected to be closed in fiscal year (FY)23. However, upon subsequent update to the OSD screening levels for PFAS in July 2022, and comparison to the SI levels, the Army determined that this site would remain open, and the investigation will move into the remedial investigation (RI) phase for Current Fire Station, Fire Station Support Storage Facility, Helipad-AFFF Equipment Testing Area, and AFF Storage Area. Cleanup and exit strategy-Preliminary results of the SI indicate the potential for four areas of potential interest (AOPI). The Remedial/Feasibility Study (RI/FS) is underway.
