### Site Narrative

A Preliminary Assessment (PA) was completed at Army Aviation Operations Facility (AAOF) Blair Hangar to assess potential poly-fluoroalkyl substances (PFAS) release areas and exposure pathways to receptors. During the PA, one Area of Interest (AOI) was identified at the Blair Hangar AAOF: AOI 1 Tri-Max™ Training Area and aqueous film forming foam (AFFF) storage Area. Based on potential AFFF release at this AOI, there is potential for exposure to PFAS contamination in surface soil, subsurface soil, and groundwater to site workers, construction workers, and trespassers at the facility. A Site Inspection (SI) is currently underway.

**Cleanup/Exit Strategy** An SI is underway. At this time, no other actions are planned. Once validated sampling results are received, future actions will be evaluated.
